## Letter to the Editor

### Best Practices for Letters to the Editor (LTEs):

- Always check the publication's specific word count limits (typically 150-300 words) and follow their submission guidelines precisely.
- Submit your letter within 5-7 days of the referenced article for maximum relevance.
- Personalize your perspective with authentic experiences rather than generic talking points. Avoid inflammatory language or personal attacks on authors or public figures.
- Include verifiable statistics from reputable sources.
- Submit your letter via the outlet's preferred method (often email) directly to the editor whenever possible and include your full contact information for verification purposes.

- Remember that most publications receive dozens of letters daily, so conciseness and a compelling opening sentence significantly increase your chances of being published.

### **SAMPLE LTE: Proposed Medicaid Cuts Threaten Oregon's Healthcare Safety Net**

The April 15th article, "Oregon Health Authority Warns of Impending Medicaid Crisis," accurately highlights the dangers, but for communities like mine in southern Oregon, the impact would be catastrophic.

As a Community Health Nurse for over 25 years, I've seen how Medicaid functions as the backbone of our healthcare system. The 187,000 residents in our region who depend on Medicaid — including 55,300 children, 16,400 seniors, and 41,900 people with chronic conditions — face potentially life-threatening disruptions if proposed cuts move forward.

Without adequate Medicaid funding, rural clinics would close, preventive care would vanish and emergency rooms would become overwhelmed. I witnessed this personally when my neighbor, unable to access his diabetes medications after previous coverage restrictions, required emergency hospitalization that could have been prevented with proper care. Currently, residents in our county must travel up to 70 miles for specialty services after our community health center reduced hours due to funding constraints.

As Congress debates proposals that could slash up to \$880 billion from Medicaid over the next decade, we must recognize that these cuts would devastate healthcare access across Oregon, from coastal communities to the high desert.

Preserving Medicaid isn't partisan politics — it's about protecting our neighbors, our families and our communities. The time to speak up for this essential program is now.

Subject: Oppose Cuts to Medicaid

Dear [Senator/Representative] [Last Name],

I am writing to urge you to oppose any policy proposals that would result in reduced federal funding for Medicaid. Medicaid is a critical lifeline for millions of Americans — including children, seniors, veterans, individuals with disabilities and low-income families — that ensures access to essential health care services.

Medicaid is not merely a budget line item; it is a fundamental pillar of our health care infrastructure.

Cuts to Medicaid would have devastating effects across our communities, likely resulting in lost employment, hospital service reductions or closures and forcing many vulnerable individuals to go without the care they need. These cuts would lead to increased health care costs for all Americans, leaving patients without the care they need and placing enormous strain on hospitals, nursing homes, health centers, behavioral health centers and many other important community health providers.

Policies that reduce funding for critical Medicaid services and programs will destabilize this critical pillar of our nation's health care system, putting lives at risk and shifting greater costs onto state and local governments that are ill-equipped to handle them.

I respectfully urge you to:

- Protect Medicaid from funding cuts and harmful policy changes that result in loss of coverage
- Oppose block grants, per capita caps or other measures that would limit access to care
- Support policies that strengthen and expand Medicaid coverage for those who need it most.

As your constituent, I urge you to stand firmly in support of Medicaid and to prioritize the health and well-being of our community over budget cuts that would harm those who can least afford it.

Thank you for your attention to this critical issue. I look forward to seeing your efforts to protect Medicaid and the patients who depend on it.

### Key Messages on Protecting Medicaid

- Medicaid provides access to essential care for children, people with disabilities, seniors, caregivers, veterans and workers in low-wage jobs who do not have access to health benefits.
- The Medicaid program plays a critical role by providing access to health care services for those most vulnerable and in need, supporting safety-net providers — particularly in rural and underserved communities — and delivering a cost-effective coverage option.

- The funding cuts under consideration would have a direct impact on Medicaid beneficiaries and their ability to access needed health care.
